This section is an analysis of all rated and unrated Exchange-Traded Funds and Other Closed-End Mutual Funds, listed alphabetically by fund name. Each company represented is measured on factors such as: Fund Type, Overall Investment Rating, Price, 52-Week High, 3-Year Total Return, Dividend Yield, Expense Ratio, Cash %, Portfolio Turnover Rate and many more, 34 in total.

Section II is a summary analysis of all Exchange-Traded Funds and Other Closed-End Mutual Funds receiving a TheStreet.com Investment Rating. These summaries are made up of several components and also contain graphs and charts to assist the user in understanding the data. Components of the analyses include: Investment Rating, Major Rating Factors, Fund Family, Fund Type, Inception Date and Ticker Symbol.

Section III and IV contain a summary analysis of TheStreet.com's Top and Bottom Exchange-Traded Funds and Other Closed-End Mutual Funds. Each list is a compilation of those Funds receiving the highest or lowest Investment Rating, listed in order by Overall Rating.

Section VI identifies the Top-Rated ETFs and Other Closed-End Funds by Fund Type. This is a compilation of those Exchange-Traded Funds and Other Closed-End Mutual Funds receiving the highest TheStreet.com Investment Rating within each type of fund, listed by Overall Investment Rating.

The Street.com Ratings' Guide to Exchange-Traded Funds ends with an Appendix containing three sections: What is a Mutual Fund, A section explaining how ETFs, Open-End and Traditional Funds differ, Performance Benchmarks and Exchange-Traded Funds Summary Data.
