Chapter one begins with an Overview of Special Education. Topics included in this chapter are the first recognition of special education, Assessment and Evaluation, Individualized Educational Plan and Assessment, Inclusion, and Parental Involvement and the Need for Parent Education. Chapter two shows the Chronology of Special Education. It presents a timeline of a review of the laws, court decisions, and related developments pertinent to the recognition and support of special education in the United States.

Chapter three focuses on Special Education Curriculum. Curriculum can be viewed as anything that occurs in the education and program during the school day. It is important that the curriculum for all students meet their learning needs and abilities. This chapter shows how a multidisciplinary team of members within the child's school and community will assist with the recognition, diagnosis, learning processes, and development.

Chapters four and five discuss Special Education Programs and the Law, and Politics and the Special Education Challenge. Chapter four discusses the development of special education programs, based on laws passed to create educational opportunities, and how those laws have developed and changed. In special education, educators spend a great deal of time on the goals and objectives identified in the Individualized Education Program. Chapter five discusses the politics behind the reform of special education, with topics from the development of teacher unions and the effects of policies and political changes on special education.

The second half of this directory contains support information for anyone looking for specific people, places, and services. Chapter six contains Primary Documents and Quotations and provides the differing thoughts on how best to support special education. Chapter seven lists the Organizations, Associations, and Government Agencies that support the special education community, with national contacts, free medical services, federal assistance, and transportation services. Chapter eight contains print and non-print resources, things like books, CDs, journals, and web directories to toys, educational software, and assistive devices.

Concluding this directory is a 26-page Glossary contains all the terms, laws and acronyms that the reader might not be familiar with as well as an 11-page multi-level Index for readers who are looking for information on specific topics.
